Studio Bleu Dance Center On-line Technology Consent Form

Studio Blue Dance Center has made the decision to allow teachers to utilize Zoom, a web-based communication program a video conferencing capability a useful and effective means for accomplishing instruction and maintaining community during the government mandated closure caused by the COVID-19 virus. We are committed to continuing to provide a quality education to our students in spite of requirements to maintain social distancing. This technology will be a valuable aid and will help to provide a sense of continuity for students. The Terms of Service and Privacy Policies of Zoom state that users under the age of 16 are permitted to utilize Zoom's services. Zoom relies on the studio to obtain parental permission for students to use their site.

Zoom allows for the teachers to control chat features. Teachers are also able to mute/un-mute participants and prevent them from un-muting themselves as well as disabling screen sharing between users. No one can join a meeting without the teacher's permission.

Cancellation Policy

I understand and agree to pay the stated non-refundable fees for participation in Studio Bleu Dance Center including: registration fees, class tuition, recital costume, company fee, competition, prop fee and all vocal programs. I understand that tuition fees will continue to be charged until the studio is notified of class withdrawal in writing (30 Days in Advance). Fees are non-refundable! Classes can be conducted in-person or virtual.

Studio Bleu Dance Center Competition Team Cancellation Policy

I understand and agree that there will be a team cancellation fee of \$350.00 if the dancer withdraws from team after September 15th of each year!

Studio Bleu Voice Lessons/Vocal Groups/Theater Program!

I understand and agree that there will be a **Vocal Group** cancellation fee of \$200.00 if student withdraws from Vocal Group before May of each year! I understand and agree that tuition will continue to be charged until the studio is notified in writing (60 Days in Advance). Fees are non-refundable!

ASSUMPTION OF RISK / WAIVER OF LIABILITY / INDEMNIFICATION AGREEMENT

In consideration of being allowed to participate on behalf of **(Studio Bleu Dance Center)** dance program and related events and activities, the undersigned acknowledges, appreciates, and agrees that:

2. I willingly agree to comply with the stated and customary terms and conditions for participation as regards protection against infectious diseases.
